Joseph was born in Perry County, Indiana on September 12, 1929 to Herman F. and Verna M. (Luecke) Bruggenschmidt. He married Jacque Schneider on at November 30, 1968 in St. Joseph's Catholic Church in Jasper, IN. Joseph was a 1948 graduate of Tell City High School and a 1957 graduate of Purdue University. Joseph served during the Korean War as an enlisted U.S. Marine Corps Infantryman and received the Purple Heart for wounds received in action. He was a self-employed consultant forester and Christmas tree farmer. He was an Indiana State Senator and State Representative for 16 years. He served as a Representative for the Department of National Resources Commission and on the State Department of Natural Resources and Water and Mineral Advisory Council. He was awarded the Sagamore of the Wabash award. He was a member of the Southern Indiana Leatherneck's Detachment #931 of the Marine Corps League. He was also a member of St. Joseph's Catholic Church in Jasper, and a lifetime member of both the V.F.W. Post #673, the American Legion Post #147, and the Knights of Columbus.
